**PROPOSED CHARTER AMENDMENT**

To amend Article II, Section 5, Paragraph 2 and a new Paragraph 3 be added as follows:

Except as may otherwise be provided by this Charter, or laws of the State of Ohio governing Civil Service, the Mayor shall have the power to appoint, promote, transfer, reduce or remove any officer or employee of the City, except

- (a) those required by this Charter to be elected, and
- (b) those whose terms of office may be fixed by this Charter.

All appointive officers may be removed by the Mayor, provided however, that such removal shall not take effect without the concurrence of two-thirds of the full membership of Council.

The Mayor or any person serving as an appointive officer shall not, directly or indirectly, solicit, contract for, receive or be interested in any profit or emolument from or on account of any contract, job, work or service with, or for, the City. Any such contract in which the Mayor and/or any appointive officer is, or may become interested, may be declared void by Council.






**PROPOSED CHARTER AMENDMENT**

To amend Article IV, Section 1, Paragraph 4 to add a sentence to the end of Paragraph 4 and new Paragraph 5 be added as follows:

The Director of Finance term shall begin the first day of April of each Mayor's term in office.

The Director of Finance shall reconcile the funds of the City and provide a detailed reporting of the same to the City Council and Mayor on a monthly basis. The reconciliation of the bank statements must be performed by the Assistant Finance Director or qualified individual in order to have a complete checks and balances within the City. The Director of Finance and Mayor are the only two persons provided with permission to manage the disbursement of city funds through the local banking facility.








Section 3. Vacancy of Director of Finance, Director of Law, and/or Director of Public Service/Safety

In case of the death, disqualification, removal or resignation of the Director of Finance, Director of Law, and/or Director of Public Service/Safety, their successor shall be appointed by the Mayor, subject to confirmation of the majority of Council, for a period not to exceed the current term of office for which they are being appointed.







